## **INSTRUCTIONS FOR RENEWAL OF VEHICLE PROTECTION PRODUCT WARRANTOR REGISTRATION**

Vehicle protection product warrantors are required to renew their registrations on or before Dec. 31 of each year with the Department of Consumer and Business Services in order to issue, sell, or offer for sale a vehicle protection product warranty in Oregon per ORS 646A.436(4).

To renew your registration, complete Form 440-4785 and return it with your \$25 renewal fee to the address on the form.
